Consistory Notes - May 13, 2020

We opened with prayer and devotions.

The elders shared their meetings of April 22, April 29 and May 6. All of these meetings addressed the needs of the congregation during the COVID-19 pandemic and explored what would it look like to have in-person worship again.

Recommendations would be shared with the full consistory. Highlights of one of the meetings where medical professional Justine Wyma was shared.

It was shared there will be no spring Central Iowa Classis meeting because of COVID-19. Also all assessments for 2020 have been reduced by 30% because of COVID-19. General Synod for 2020 has been postponed for 2020 but a special session is scheduled to be held in October 2020 (TBD).

It was shared that First Reformed has been notified that we have been left in the will of Wilma Rozendaal. We will be receiving 1/10 of the estate. There are no stipulations on the use of the estate.

The deacons shared their report. General Fund giving -\$33,490; Mission Fund - \$7,070; Building Fund - \$1,101.75. Balance as of 4/30/2020 – General Fund - \$40,812.95; Mission -\$24,359.86. The treasurer's reports were approved.

The executive committee submitted a report on a plan to reopen church to in person worship. The plan was presented with the logistics needed to meet the Iowa's COVID-19 guidelines on social distancing and the responsibilities involved in having public worship services.

The consistory voted to approve the plan subject to revisions when and where if needed and set the day to reopen in person worship for Sunday, May 24, 2020.

This will apply to morning worship only. Sunday evening worship is on hold for the foreseeable future. All other ministries that are held at church are also on hold as well until the impact of the COVID-19 restrictions are lessoned.

A full detailed guideline on what Sunday in person morning worship will look like will be published for the congregation prior to our resuming services.

It is noted the consistory (elders & deacons) will be taking the initial volunteer roles needed to begin in person worship.

Sully First Reformed Church—Reopening Guidelines 5/13/2020

Dear members of Sully First Reformed, we the consistory have voted and approved a plan and set of guidelines to have **in person church services again, beginning May 24, 2020**. We look forward to meeting in fellowship and praise to our Lord and Savior. In the best interest of our health and the health of others we ask you to follow these guidelines. First if you are ill or have been exposed to Covid -19, or do not want to risk being in social groups yet, please stay home and watch the service on line.

Entering Church:

- As you enter church, a greeter will be at each door to open it for you, and give directions. As you enter the church a table with hand sanitizer, a mask if you want to use one (please take mask home with you for disposal), and a box for your offering will be available. There will only be three entrances used at this time.
- From the north parking lot, enter into the north door of the Gathering place, and move into the hallway, and proceed to the left up the steps into the front of the sanctuary, and fill seats from the front to the back or proceed into the wing. Someone will help direct you to open spaces.
- From the south parking lots enter either the south door of the Gathering place or south doors of the sanctuary. The elevator will be available for use. Go up the steps and to the sanctuary, we will use the outside aisles, to seat people using every other row of chairs. We ask to maintain a three chair spacing between families, If parents and grandkids want to sit together they may without spacing.
- The Gathering Place will be roped off and only used for overflow if seating capacity is reached in the wing and main sanctuary.
- All other entries will be locked, no entry into the basement, balcony, church office, kitchen, or Legacy room.
- Drinking fountains will off limits.

Exiting Church:

 After the service is over people will be dismissed by rows to help maintain distancing. Doors will be propped open weather permitting.

Additional Information:

- We will be taking pictures of the congregation before the service begins for future reference. Why? In case an individual contracts COVID-19, those around them can be notified.
- Bathrooms in the Gathering place and by the elevator will be open, please limit number of people using at one time. There will be no coffee time after the service.
- There will be no nursery or children's church at this time. We hope to start these ministries at a later date.
- The church service will be limited in some areas. We will only sing three songs, two at the start of church and one at the end of the service. When social guidelines relax, a children's message will be given.
- Offering boxes will be placed at church entrances.
- Impact and Faithwalkers leaders will be working on plans with their groups as options become available.

We would like to encourage everyone to come to church again when they feel comfortable attending, we are implementing these guidelines so that those who want to attend can do so in a safe manner.
